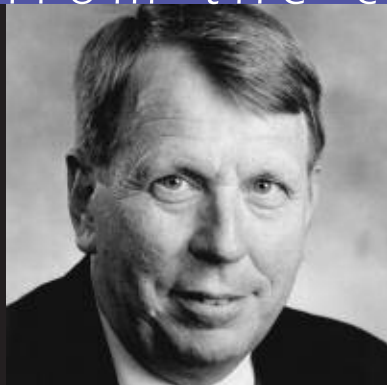

When I wrote last year's letter, I never believed that the Foundation's accomplishments this year could exceed the previous year. This annual report reflects a foundation that has continued to prosper and expand for its seventh consecutive year. This growth has come through dedication, commitment, and a creative vision to fulfill the Foundation's mission "to enhance quality of life, today, and in the future."

A few of the highlights that note celebration include:

- The Foundation more than doubled in total assets from \$15 million to more than 34 million.
- More than \$1.7 million in grants were awarded.
- Nineteen new funds were added this past year bringing a total of 195 funds established with the Foundation.
- A Make a Wish Come True catalog was introduced to serve nonprofit organizations by enabling them to make their specific needs known throughout the community.
- The PET Project (Philanthropy, Empowerment and Transformation), established last year for young donors,

raised \$8,700 for a grant to the Center for Prevention of Hate Violence to work with high school students and raised an additional \$2,125 to add to the PET Project endowment fund.

I would be remiss if I did not recognize our excellent Foundation staff for obtaining national accreditation from the Council of Foundations. Out of the 700 foundations in the United States, 500 foundations have indicated a desire to obtain accreditation, while only 150 have thus far been accredited by meeting the stringent national standards.

Looking forward to next year, we are excited to be relocating to our new facility on 7th Street that will provide a large meeting room which will be available not only to the Foundation but also other nonprofit organizations.

On behalf of the board and staff I want to thank the many who have been a part of building and sustaining the Foundation. We not only celebrate our successes and continued growth, but also respect the challenges ahead as we continue striving to fulfill our mission.

our mission

The mission of the Greater Salina Community Foundation is to enhance quality of life, both today and in the future, by:

- enabling donors to fulfill their charitable desires
- building a permanent endowment
- facilitating prudent management and care of funds
- meeting needs through grants, awards, and scholarships

benefits of giving through the foundation

Tax Benefits—Our status as a public charity ensures that contributions to the Foundation are tax deductible to the highest extent allowed by the Internal Revenue Service.

Flexibility and Simplicity—Individuals, families, companies or charitable organizations can create a fund in the Foundation that is tailored to their specific needs. Donors who wish to establish their own philanthropic fund can avoid the complexity of setting up a private foundation, yet enjoy similar benefits in grant making with a donor-advised fund. A fund in the Foundation can be created quickly and efficiently. The Foundation staff provides consultation and guidance. For more information on starting a fund, give us a call at the Foundation office.

Recognition or Anonymity—Most donors create a permanent legacy by setting up a fund in their name or the name of their family. However, the Foundation will also protect the identity of donors who wish to remain anonymous.

Cost-Effective Giving Options—There is no cost to set up a fund. With annual board approval, an administrative contribution is assessed from each established fund. This contribution is never more than 1% of the annualized fair market value of an endowed fund. The Foundation manages a pooled investment fund under the guidance of our Investment Committee. By pooling funds, we are able to provide donors the advantage of diversified investments and economies of scale in investment fees. Donors who establish funds of \$25,000 or more may request an outside fund manager.

Responsible Leadership—A 24-member volunteer board of directors governs the Foundation. Foundation staff includes the president and executive director, the finance officer, the youth coordinator and an administrative assistant. Our capable staff manage the Foundation on a day-to-day basis. The Foundation adheres to strict national standards established by the Council on Foundations. In addition, the Foundation is annually audited by an independent firm. Tax returns and public disclosure of grants provide confidence as to the proper use of Foundation funds.

The Power of Endowment—The Foundation offers a variety of giving options, both endowed and non-endowed. However, it is the power of the endowed fund that sets community foundations apart. Endowed funds are invested and earnings are used to make grants addressing community concerns. These funds are a permanent source of community capital—helping to meet important community needs both today and in the future.

Finances

The Foundation more than doubled our assets last year, going from \$15 million to more than \$34 million.

Many generous gifts, including the termination of a large private foundation into a donor advised fund, resulted in another year of phenomenal growth. Learn more about the benefits of a donor advised fund vs. a private foundation on page 24.

In addition to the generous donations received, earned income was also positive, with the pooled investment fund managed by the Foundation earning 9.84% for the fiscal year ended June 30.

Grants

Not only did the Foundation double in assets, but also in grants awarded.

More than \$1.7 million in grants were awarded from donor advised, organization, designated and pass-through funds, as well as from the Foundation's own community grant programs. Partnerships with local and state-wide foundations have increased the grant making capacity of the Foundation.

Funds

Each year more funds are entrusted to the Foundation's Care. Nineteen new funds were added this year, bringing the total number of funds to 195, including donor advised, designated, field of interest, organization, pass through, provisional funds, scholarships and our own unrestricted grant funds.

Make A Wish Come True Catalog

The Foundation introduced a new giving catalog last year to serve both nonprofit organizations and donors. The Make A Wish Come True Catalog included needs from local nonprofits that ranged from boxes of crayons to buildings and vehicles. Catalogs were distributed through the public library, downtown cafes and by mail.

Blueprint for Leadership

The Foundation's Blueprint for Leadership program has now graduated four classes. Another community class is scheduled for winter of 2007 and a special class targeted to early childhood professionals will be offered this fall. Blueprint for Leadership is an interactive, skills-based leadership program designed in cooperation with the Kansas Health Foundation. An important part of the program is the completion of a class project that benefits children and youth in our community. Learn more on page 10.

Youth GrantMakers Council

In its second year, the Youth GrantMaker's Council added eight new members and more than doubled its grant making. These young people are learning the joys and responsibilities of giving, as well as how to build consensus, research community needs and the value of committing themselves to improving their community. Philanthropy, Empowerment and Transformation, The PET Project grew this year to include 45 couples or individuals the Foundation brought together to make a significant grant in the community. 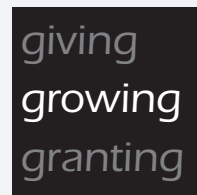
Education

The Foundation continued our commitment to philanthropic education by bringing outstanding speakers to a variety of important audiences. In the fall, Kathryn Miree, an attorney and speaker from Birmingham, Alabama, conducted workshops for professional advisers and development staff, as well as for donors. Ms. Miree focused on estate-planning issues and creative ways to meet client needs for family and charitable giving through trusts, annuities and other vehicles. In the spring, Salina attorney John Mize spoke to representatives from local nonprofit organizations about governance and the roles and responsibilities of nonprofit boards. The Foundation's ability to provide quality education programs is made possible through the generous support of our Education Partners. See the inside back cover for a list of Education Partners.

Citizenship Award

Salinans Ted and Vera Zenger were honored by the Foundation in May, as recipients of the Salina Award for Outstanding Citizenship. Among their many gifts to the community, Ted has served as the master gardener for the Salina Emergency Aid Food Bank, and Vera was instrumental in establishing the Salina Cares Clinic, now the Salina Family Healthcare Clinic, serving the medically indigent population. The Zengers are known for their dedication and modesty.

The Greater Salina Community Foundation is one of only 150 community foundations across the country that has been recognized for having organizational and financial practices in accordance with the National Standards for U.S. Community Foundations. In order to achieve this recognition, the Foundation underwent an extensive review of organizational and financial policies and procedures. "Being recognized by the Council for meeting these rigorous standards demonstrates our ongoing commitment to quality and provides an additional indication of trust for our donors and the entire community," said Betsy Wearing, President and Executive Director.



The Council on Foundations and leaders of the community foundation field created the National Standards in 2000 to aid community foundations in establishing legal, ethical and effective operational practices that show foundations' transparency and financial responsibility in light of the increased public scrutiny of foundation practices. In addition, National Standards were developed to distinguish community foundations from other philanthropic vehicles. The 43 National Standards address six key areas of community foundation operations:



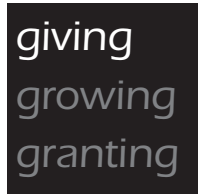
- Mission, Structure and Governance
- Resource Development
- Stewardship and Accountability
- Grant-making and Community Leadership
- Donor Relations
- Communications

U.S. community foundations serve tens of thousands of donors and administer more than \$39 billion in charitable funds. Of the nearly 700 community foundations in the United States, more than 500 have pledged to comply with the National Standards, and of those, 150, including the Salina Foundation, have been found in compliance.

The Council on Foundations is a Washington, DC-based nonprofit membership association of more than 2,000 grantmaking foundations and corporations.

A new partnership with the Salina Regional Health Foundation's Community Health Investment Program (CHIP) was established last year. This partnership has enabled the Foundation to better respond to the many requests for

funding we receive each spring and fall. Many of the requests received by the Foundation fall within CHIP guidelines. A generous contribution from CHIP now supports grant requests that meet that program's criteria to serve children and youth. This partnership enables the Community Foundation to stretch our unrestricted grant

dollars and serve more community needs.



CHIP GRANTS AWARDED IN SPRING 2005

Assaria Summer Youth Program \$2,000 — Provided funding for K-8th summer camp program that provides quality educational and recreational opportunities for children.

Boy Scouts of America \$1,400 — Provided assistance with the Juvenile Diversion Program assisting youth ages 10-14 who are first-time offenders. Youth who successfully complete this early intervention program and stay straight can have their crime removed from their permanent record.

Central Kansas Foundation \$1,500 — To develop a family-friendly indoor and outdoor play area for children who are visiting family members in treatment.

Cottonwood Elementary School PTA \$1,500 — Furnished funds to implement the Character Education Program. The program teaches values that will prepare children to be better members of their communities.

Grace E. Stewart Elementary School \$1,600 — To purchase Literacy Bags. Literacy Bags provide reading and writing activities in conjunction with a particular story for students K-2. The bags also encompass math and science activities designed to be fun and promote reading.

Heartland Programs \$1,900 — To support a licensed dietician who will oversee the summer lunch program. The lunch program provides at-risk students a free and nutritious lunch. The additional dietician allowed more sites to be available this past summer.

St. Francis Academy \$1,700 — To purchase supplies and materials for St Francis Academy's Creative Arts Therapy Program. This program will help youth in residential treatment to learn appropriate communication and social skills through the exploration of creative arts.

St. John's Missionary Baptist Church \$1,900 — Funding for Kid's Kare staff. Kid's Kare is an after-school program designed to help school-age children improve their behavior and academic performance.

Salina Child Care \$2,000 — Purchase of child-sized furniture and toys to replace worn-out materials for the infant/toddler play area.

Southeast of Saline Education Foundation \$1,800 — Funding to purchase landscape items for an outdoor learning lab that will benefit students K-12.

Sunrise Presbyterian Church-CASTLE \$1,200 — To purchase movable storage units for the CASTLE project, serving children of low-income, working families, with adult-supervised activities during the summer. The project provides nutritious meals and fun, healthy activities for children 3-12.

Salina Fire Department \$1,000 — Provide funding to purchase a new costume head for "Sparky". Sparky teaches children fire safety lessons that reinforce fire and life safety messages.

Total — \$19,500

Leadership class. Worms were wriggling, apples were crunching and fingers were busy digging in soft dark

soil. More than 100 children from kindergarten through 6th grade were immediate benefactors of the 2006 Blueprint for Leadership class. Worms were wriggling, apples were crunching and fingers were busy digging in soft dark soil. On a crisp morning in June, members of the class hosted children from the Salina Family YMCA's Camp SWAT for an adventure in gardening.

"To Go Gardens" was the cumulative brainchild of class members. Each brought his or her own unique talents to the project. The children visited a variety of stations set up in Kenwood Park to

learn about a variety of issues related to growing food. Hands-on lessons

included why we should learn about and care for our precious soil; how to give worms a "bath" in the dirt and the value and role these slimy creatures play in our food production. At still another station students created pictures of gardens, plants, and fields. Finally, each child was given a pot, a plant and a shovel. With help from class members, they carefully planted their dwarf pumpkin plants. Each plant was given a drink and the children were taught how to care for their little garden.

Blueprint for Leadership is offered at least once every year. The course teaches leadership skills including visioning, learning styles, collaboration, problem-solving, consensus-building, creative thinking, learning cycles and group dynamics.

Class projects like "To Go Gardens" are an important part of the course. Members of the class determine the project based on perimeters outlined by the Foundation, which provides the funding. Using their newly honed leadership skills class members plan and execute the project.

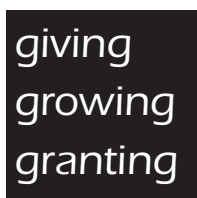

What could you do with \$500? A few cans of paint, lots of organization, planning, teamwork, elbow grease, and the creation of a new organization... together with \$500 from the Foundation's Youth GrantMakers Council resulted in the makeover of a community park and the creation of "FRAPP".

Fifteen-year-old Chloe Seim applied for a YGMC grant to spruce up the Assaria Community park. She knew what she wanted to do, but quickly learned that

there might be more to making it happen than she originally thought. "Soon after my application was accepted, I found out just how much work it can be to run a project," she admitted. But Chloe and a group of friends she assembled, calling themselves Freshmen Rebuilding the Assaria Park Project, or FRAPP, were persistent in

their quest, and on June 23 and 24, 2006, they gathered in the park for the makeover mission.

They accomplished many improvements, including:

- Scraping, priming and painting all bleachers, benches and picnic table
- Primed and painted all metal playground equipment
- Replaced two basketball nets
- Scraped, primed and painted baseball dugout benches
- Painted new lines on the basketball court
- Planted a Redbud Forest Pansy Tree
- Planted a Cleveland Pear Tree
- Painted the outside of the bathhouse, including a handprint border and detailed mural

The students selected Southeast of Saline colors (purple and white). They thanked city officials and parents who helped in the planning process. When the project was finished, they had accomplished their goal and had \$1.80 left of that original \$500.

In her grant report to the Foundation, Chloe wrote, "It was unbelievable how much we achieved in only two days, and how my volunteers went beyond what I had hoped...I want to thank the Youth GrantMakers Council. You gave me the opportunity to help the people I love and do something that involved the environment. Without this council and the Greater Salina Community Foundation, my dream would have never come true, nor would we have been able to improve the lives of the young Assaria children."

The Russell County Area Community Foundation has been given a unique opportunity

from the Kansas Health Foundation and a generous gift from Senator Bob Dole, a Russell native. The Health Foundation has offered the Russell affiliate participation in the GROW Program, designed to establish and grow community foundations in select rural communities. As a result of this new venture, the Greater Salina Community Foundation has hired an executive director and established a local office in Russell. Byrne Wood began work this summer. Wood and his wife, Rosalie, have lived in Russell for more than 30 years. He is a retired insurance and investment executive. He directs the choir at the Trinity United Methodist Church. His first significant goal for the GROW program is to raise \$300,000, which will be matched by the Health Foundation and then used to fund his position and the office for the Russell Foundation. Senator Dole kicked off the fund raising effort with a generous gift of \$100,000.

Youth GrantMakers Council operates as a foundation within the Foundation. In its second year, the council was made up of seventeen high school students from Salina South, Salina Central, Sacred Heart, and Southeast of Saline.

Council members began their year interviewing and determining whom to select to join the council. They then started their work with a teambuilding retreat. Over the course of the

school year, YGMC met at least every other week.

For the first time, the council elected officers who created agendas and ran the meetings, kept minutes, and worked closely with the Foundation's Youth Coordinator, Kelli Schwarz-Rump. Throughout the year the council spent time marketing grant opportunities to other youth in the community, following up on grants awarded the previous year, and making decisions on current grant applications. An added challenge was the addition of a second grant cycle. YGMC awarded a total of \$6,000 in grants. In addition, many of the council members served the community through the Big Brothers Big Sisters lunch buddy program.

One highlight of the year was an invitation to serve as the primary presenter at a program for gifted students from all over central Kansas. The event was at Ell-Saline High School. Members of the council presented information about how YGMC works. They discussed grant-making and then did hands-on activities with the students to teach them how to apply for grants. Council members led a brainstorming session about possible projects that could better the lives of the youth in the area.

In 2006, young donors again came together with the help of the Greater Salina Community Foundation to offer a significant grant to benefit youth in our community. The donors picked the project. The Foundation facilitated the administration and grant process. By pooling their contributions, the PET

Project participants were able to make a more significant impact on a particular program or project.

The 2006 PET Project grew by more than 60% this year, with 45 couples or individuals participating in the Project. Together, these donors contributed \$10,825 to the PET Project. Of that, \$8,700 was distributed to the

2006 grant recipient. The remaining \$2,125 was added to the PET Project endowment.

This year's grant recipient was Child Abuse Prevention Services. CAPS coordinated a 5-day residency with Chris Littlefield, a specialist from the Center for the Prevention of Hate Violence. Chris spent 5 days working with students and faculty at Salina Central and Salina South High Schools. Chris conducted all day workshops with student leaders, both positive and negative, to open the door to a more positive culture in the schools. Chris was also able to do some follow-up workshops at South and Lakewood Middle Schools, where he had worked with students last January.

Donors, Foundation staff and school officials were all are excited about this project, which directly addresses some of the turbulent issues our local high schools are facing regarding student relations and violence.

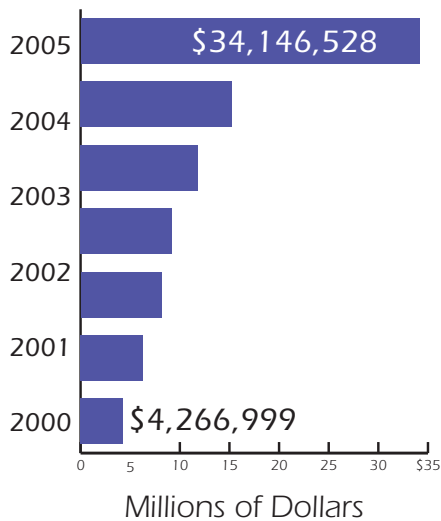

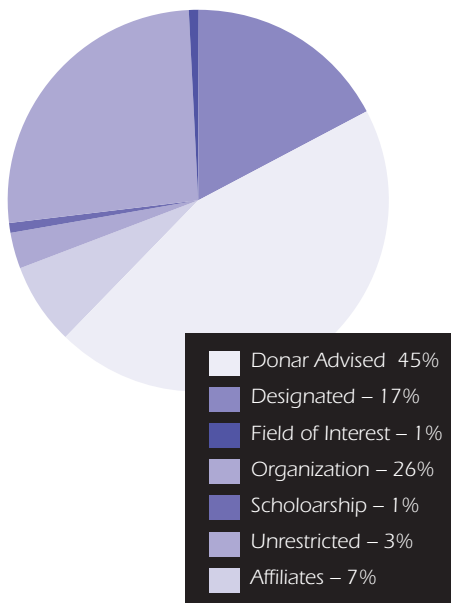
